# THE ALIEN PRESENCE

## MAJESTY REPORT

"I occasionally think how quickly our differences world-wide would vanish if we were facing an alien threat from outside this world. And yet, I ask you, is not an alien force already among us?"

SUBJECT: FLYING SAUCERS  
INFORMATION CONCERNING

DATE: March 22, 1950

The following information was furnished to SA [redacted]

An investigator for the Air Forces stated that three so-called flying saucers had been recovered in New Mexico. They were described as being circular in shape with raised centers, approximately 50 feet in diameter. Each one was occupied by three bodies of human shape but only 3 feet tall, dressed in metallic cloth of a very fine texture. Each body was hunched in a manner similar to the blackout suits used by speed flyers and stunt pilots.

According to Mr. [redacted] informant, the saucers were found in New Mexico due to the fact that the Government had a very high-powered radar set-up in that area and it is believed the radar interfered with the controlling mechanism of the saucers.

No further evaluation was attempted by SA [redacted] concerning the above.
